實用面積的定義 Definition of Saleable Area

實用面積是指個別單位獨立使用的樓面面 積,包括露台、工作平台及其他類似設施, 但不包括公用地方,如樓梯、升降機槽、入 牆暗渠、大堂及公用洗手間。實用面積是量 度至外牆的表面或共用牆的中線所包括的 面積。天井、窗台、冷氣機房、花槽、平台、 附屬天台及車位並不包括在內。遇到極厚的 ,所採納的厚度最多不能超逾 230毫米。 原來設計爲天井或單位附屬平台的空間,如 建有上蓋、大部分圍起及當作單位不可分割 的部分使用,在評估差餉或地租時可被視爲 實用面積的一部分。有關房屋委員會或房屋 協會興建的物業,其實用面積由該委員會或 協會提供。

Saleable area is defined as the floor area exclusively allocated to the unit including balconies, utility platforms and other similar features but excluding common areas such as stairs, lift shafts, pipe ducts, lobbies and communal toilets. It is measured to the exterior face of the external walls and walls onto common parts or the centre of party walls. Open yards, bay windows, air-conditioning plant rooms, flower boxes, open terraces, attached roofs and carports are excluded. A maximum thickness of 230 mm is adopted as the thickness of unduly thick walls. Where space designed as an open yard or an open flat roof attached to a flat is covered and substantially enclosed and used as an integral part of the flat, it may have been included as part of the Saleable Area for rating or Government rent purposes. For properties built by the Housing Authority or Housing Society, the saleable area is based on the area supplied by the said Authority or Society.
